The mission of the Rocky Mountain Conference is to lovingly support and empower every member in our conference to know Christ and to make Him fully known through education, outreach, and service, and by communicating hope and encouraging an intimate connection with each other and with Christ.

The mission of the Glacier View Ranch Summer Camp Program is to make it as easy as possible for every camper to gain a personal knowledge of God by fostering an authentic relationship with Jesus Christ and with one another through the use of recreation, retreat, and nature-based activities.

Job Summary:

The RZRs and Rock Crawling Instructor at GVR is responsible for implementing a successful RZR/Crawling program that emphasizes safety and utilizes age appropriate lessons and routes that are fun and engaging for campers of all skill levels and abilities.

Duties and Responsibilities:

- Lead rock crawling classes in the mornings and afternoons.
- Use creative ideas to make the activity fun.
- Develop, review, and/or implement rules that will guarantee a safe environment for those who participate in the RZR and Rock Crawling program.
 - Conduct a safety orientation before the start of each activity period.
 - Ensure the safe operation of all equipment before campers ride.
 - Check all equipment for safety each day before classes.
- Maintain consistent safety rules that may include, but are not limited to, the following:
 - Helmets are required at all times.
 - Bumping, crowding, and reckless driving is prohibited.
 - Participants with long hair must have it pulled back under the helmet.
- Work with the RMC Youth Director to maintain safe and clean rock crawlers and RZRs.
- Assure that environmental hazards are not severe enough to cause danger to children.
- In the event of an emergency, contact the Camp Director and/or Assistant Camp Director and Camp Nurse as soon as possible.
- Perform any additional summer camp related duties as assigned by the Assistant Camp Director, Camp Director or RMC Youth Director.

Performance Factors:

The following Performance Factors are used during the annual review process to determine if the employee is meeting job expectations

- Employee can be depended upon to complete work in a timely, accurate, and thorough manner and is conscientious about assignments.
- The employee communicates effectively both verbally and in writing with supervisors, colleagues, staff, campers, parents, etc.
- Wearing the armor of the Fruits of the Spirit, the employee exhibits a professional manner in dealing with others and works to maintain constructive working relationships.

Qualifications/Requirements:

- Be committed to the Seventh-Day Adventist Church and its mission
- Be at least 18 years of age
- Possess a valid state-issued drivers license in good standing.
- Have no more than 2 moving violations in the past 3 years.
- Have prior experience in the safe operation and maintenance of Off Highway Vehicles
- Have a minimum of four (4) hours training on the safe operation of Off-Highway Vehicles
 - Training to be signed off by RMC Youth Director, Camp Director, or Camp Ranger
- Hold certifications in CPR and First-Aid including Blood Borne Pathogens
- All drivers will have knowledge of Colorado Child-Care rules governing camper transportation and staff-to-camper ratios
- Understand Glacier View Ranch Summer Camp policies, expectations, and safety procedures as outlined in the staff manual
- Competencies (skills and personal characteristics that an individual should possess in order to be successful in this position)
 - Planning/organizing
 - Analytical
 - Critical thinking
 - Time and organizational management

Typical Physical Demands:

While performing the duties of this job, the employee must be able to stand and/or walk for extended periods of time. The employee must be able to read, speak, and hear. Must be able to effectively communicate in English, both orally and in writing. While performing the duties of this job, the employee is regularly required to stand, sit, talk, hear, walk, run, bend, kneel, reach overhead and may often lift up to 40 pounds. The employee must possess excellent driving and navigating skills. The employee must be able to climb into tall vehicles with roll cages. The employee is required to use stairs. The employee must be able to respond quickly and rationally in potentially dangerous situations, especially when others are in trouble.

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Working Conditions:

The employee may be exposed to unpleasant and noxious fumes and odors. At times, the job may require an employee to be exposed to hazardous work environments. Some jobs require an employee to work where there is a significant chance of injury. Employee is expected to take necessary precautions for all work-related job duties. Essential responsibilities are performed while sitting, standing, kneeling, or driving. This position is highly demanding and requires great flexibility and responsiveness. Tasks are performed in a variety of locations and conditions around Glacier View Ranch, including the camp and National Forest’s mountain trails. Additional duties are performed in rugged outdoor areas as well as in indoor facilities such as the lodge and cabins. Indoor work areas are typically well lighted and ventilated; however, the camp is located in the mountains at a high altitude.

Employee will be exposed to the elements (rain, sun, wind, etc.). The position is a full-time, seasonal/temporary role and requires work hours that include evenings and weekends. The workweek is defined as Sunday through Saturday.

The tasks, duties, responsibilities, functions, skills, talents, etc. outlined in the description is not an exhaustive list and should not be construed as such. The Rocky Mountain Conference reserves the right to modify this job description as/when needed in order to fulfill the mission of the Conference.
