## Job Summary:

The Team Sports Instructor develops and instructs sports and physical education classes for campers of all ages and skill levels that emphasize fun, learning, and safety.

## Duties and Responsibilities:

- Design a rotation of different sports for each day.
  - Example: Soccer, Basketball, Softball, Badminton, Ultimate Frisbee
  - Instruct campers on basics of each sport selected for the camp program and advance only as the campers are able
- Teach morning and afternoon team sports classes as specified by the daily schedule.
  - Anticipate 4 to 5 classes per day, 5 days per week.
- Provide and encourage a Christ-like atmosphere for good sportsmanship and team building activities
  - Teach respect for teammates and opponents
- Hold responsibility for all equipment and supplies associated with the sports program.
  - Provide a written inventory to the Activities Director at the beginning and end of the summer camp program.
  - Provide the Activities Director with any needs regarding sporting equipment.
  - Store all gear when not in use.
- Encourage each camper and staff that participates in the team sports program.
- Encourage discovery and development of personal skills.
- In the event of an emergency, follow the GVR's emergency action plans.
  - Contact the Camp Nurse or Camp Director and/or Assistant Camp Director as soon as possible.
- Perform any additional summer camp related duties as assigned by the Assistant Camp Director, Camp Director or RMC Youth Director.

## **Performance Factors:**

The following Performance Factors are used during the annual review process to determine if the employee is meeting job expectations

- Employee can be depended upon to complete work in a timely, accurate, and thorough manner and is conscientious about assignments.
- The employee communicates effectively both verbally and in writing with supervisors, colleagues, staff, campers, parents, etc.
- Wearing the armor of the Fruits of the Spirit, the employee exhibits a professional manner in dealing with others and works to maintain constructive working relationships.

## **Qualifications/Requirements:**

- Be committed to the Seventh-Day Adventist Church and its mission
- Be at least 18 years of age
- Have a knowledge and/or passion for sports
- Hold certifications in CPR and First-Aid including Blood Borne Pathogens
- Certification or documented training or experience from a recognized organization
- Understand Glacier View Ranch Summer Camp policies, expectations, and safety procedures as outlined in the staff manual
- Competencies (skills and personal characteristics that an individual should possess in order to be successful in this position)
  - Planning/organizing
  - Analytical
  - Critical thinking
  - Time and organizational management

## **Typical Physical Demands:**

While performing the duties of this job, the employee must be able to stand and/or walk for extended periods of time. The employee must be able to read, speak, and hear. Must be able to effectively communicate in English, both orally and in writing. While performing the duties of this job, the employee is regularly required to stand, sit, talk, hear, walk, bend, kneel, reach overhead and may be required to lift up to 40 pounds. The employee is required to use stairs. The employee is required to be capable of participating in sports that require sustained periods of heavy physical activity such as running, sprinting, and jumping. The employee must be able to respond quickly and rationally in potentially dangerous situations, especially when others are in trouble.

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

## Working Conditions:

The employee may be exposed to unpleasant and noxious fumes and odors. At times, the job may require an employee to be exposed to hazardous work environments. Some jobs require an employee to work where there is a significant chance of injury. Employee is expected to take necessary precautions for all work-related job duties. Essential responsibilities are performed while sitting, standing, or kneeling. Tasks are performed in a variety of locations and conditions around Glacier View Ranch, including the recreation field, basketball court, and various other outdoor locations. Additional duties are performed in rugged outdoor areas as well as in indoor facilities such as the lodge and cabins. Indoor work areas are typically well lighted and ventilated; however, the camp is located in the mountains at a high altitude.

Employee will be exposed to the elements (rain, sun, wind, etc.). The position is a full-time, seasonal/temporary role and requires work hours that include evenings and weekends. The workweek is defined as Sunday through Saturday.

The tasks, duties, responsibilities, functions, skills, talents, etc. outlined in the description is not an exhaustive list and should not be construed as such.
